



Membership Request Form

Membership in the Australian Coalition of Apostolic Leaders is open to all men and women who are currently engaged in apostolic ministry within Australia. ACAL is intended to be a professional society where confirmed apostolic leaders are able to connect and relate to each other.

Yearly dues are paid by members of ACAL for the purpose of financing the administrative activities of the coalition in Australia. A portion of these dues are sent to ICAL's International Office to support its work. Individual members of ACAL are automatically given full membership in ICAL.

Definition of an 'Apostolic Leader'

An Apostolic Leader is gifted, taught and commissioned by God to function within an assigned sphere of ministry by hearing what the Spirit is saying to the Church, and is committed to establishing and extending the Kingdom of God in the earth. Apostolic leaders reflect the character of Christ, spiritual maturity, and an ability to equip the saints for the work of ministry.

Apostolic leaders have a grace that has come to them in the form of a call to be one of five types of leader: apostle, prophet, evangelist, pastor and/or teacher. These leadership roles are not limited to functions within the church but can be validly exercised within all domains or spheres of influence in contemporary society e.g. Business, Government, Justice, Religion, Creative Arts, Education, Health, Media, Sport and Welfare, etc.

Membership Procedure

1. Membership is granted only by official invitation from the National Convenor and Council of ACAL. All prospective members are asked to complete a membership request form which can then be forwarded to the National office.
2. Invitation to ACAL requires nominations to be made and seconded by any two current and active members (*see page 2*). If you do not currently know two members of ACAL, please inform our office.
3. Invitation to ACAL also requires a brief written testimony from two people who look to the nominee as one who provides apostolic leadership according to the aforementioned ACAL definition of an Apostolic Leader.
4. An application form must be completed along with payment of annual membership fees when a person is accepted for membership. It is understood that 25% of the membership fee will be forwarded to ICAL and all members of ACAL automatically become members of ICAL.
5. While ACAL is not intended to be a training ground for emerging apostolic leaders, we value raising up apprentices in apostolic ministry. Members are encouraged to invite and accompany their protégés to ACAL events.
6. Membership in ACAL is voluntary and will be considered ongoing unless a member resigns or is asked to withdraw by the National Council for moral reasons or by lack of participation or support.
7. ACAL membership fees are \$350 per person or \$600 per couple per annum and are due in July of each year. Membership fees are paid in addition to registration fees for ACAL conferences or regional events.
